



## Radojunkie Fee-Waiving Policy

### 1. Introduction

At Radojunkie, we are committed to providing accessible martial arts classes to all members of our community. We understand that financial hardship can sometimes act as a barrier to participation. In light of this, we have established a Fee-Waiving Policy to support individuals and families in need, ensuring that everyone has the opportunity to join our martial arts classes, regardless of their financial situation.

### 2. Eligibility Criteria

Fee waivers are granted based on the following criteria:

- **Financial Hardship:** Applicants must demonstrate that they are experiencing financial hardship that prevents them from affording the full cost of our classes.
- **Benefits Recipients:** Individuals or families receiving government assistance (e.g., unemployment benefits, disability benefits) are eligible to apply.
- **Students and Young People:** Full-time students and individuals under the age of 18 may apply for a fee waiver.
- **Children on Free School Meals:** Children receiving free school meals due to family financial constraints are eligible for fee waivers, ensuring equal access to our martial arts classes.
- **Young Carers:** Individuals under 18 who provide care for family members with health issues, disability, chronic illness, mental health condition, or drug or alcohol dependency, are eligible for a fee waiver., offering them a supportive outlet through martial arts.
- **Special Circumstances:** Consideration will also be given to applicants facing exceptional circumstances, such as recent job loss, significant unexpected expenses, or other situations of similar gravity.

### 3. Application Process

1. **Request an Application Form:** Interested applicants should request a Fee-Waiving Application Form by contacting Radojunkie at [contact@radojunkie.com](mailto:contact@radojunkie.com).
2. **Submit Required Documentation:** Applicants must complete the application form and provide any required documentation to support their claim of financial hardship or eligibility under the categories mentioned above.
3. **Review Process:** Completed applications will be reviewed by the Radojunkie Fee-Waiving Committee. The review process may take up to 4 weeks. During this time, additional information may be requested from the applicant.
4. **Notification:** Applicants will be notified of the committee's decision via email or phone. Decisions made by the committee are final.

### 4. Terms and Conditions

- Fee waivers are granted for a specified period, not exceeding 12 months. Recipients may reapply upon expiration of their current waiver.
- Fee waivers cover the cost of class attendance only. Additional costs, such as equipment or special events, are not included.
- Radojunkie reserves the right to modify or discontinue the Fee-Waiving Policy at any time without prior notice.
